Additionally, stewardship of those components involves knowing when and how the utilized hardware and software needs to be repaired, optimized or replaced. Keeping to these basic principles ensures that employees vital to the mission, regardless of their location, have all the assets to perform their job.

Asset Management



Appsential will work with partners to provide life cycle support of all software and hardware that adheres to recognized IT asset management (ITAM) practices. Our process, as outlined below, will allow flexibility for the customer to make sound, strategic decisions about their IT environment.

Based on extensive and carefully developed customer requirements, the team will generate an initial inventory list of necessary software and hardware. Appsential will then work with the required entities to negotiate license agreements and physically transfer assets to the customer and prepare for deployment. In the most important step of this process, the team will systematically tag all new hardware assets. The physical security of all property is paramount to an entity's day-to-day operation, so asset tag control will be regularly administered and maintained via dedicated staff members. Similarly for software assets, configuration control will be put in place for all developed code and applications, ensuring the authoritative versions of any software are in use at all times. Once all asset management controls are in place, the new resources will be deployed or delivered to the field. Basic review, adjustment, and maintenance of all licenses, agreements, and configurations will be carried out regularly. Finally, on a predefined basis (semi-annually or annually), current inventory will be appraised for continued applicability to the mission. In the event that some or all current assets no longer meet the customer's needs, or the customer's needs have expanded or changed, the team will reassess and restart the ITAM process, as indicated in the figure above.
